Key Indicator 1: Business Structure

- Description: Determine the legal structure of your business (sole proprietorship, partnership, LLC, corporation).

Key Indicator 2: Business Name

- Description: Choose a unique business name and check availability with the Florida Division of Corporations.

- Pricing: Filing fee for registering a fictitious name (\$50)

Key Indicator 3: Obtain Federal EIN Number

- Description: Apply for an Employer Identification Number (EIN) from the IRS.

- Pricing: Free

Key Indicator 4: Register with Sunbiz

- Description: Register your business with the Florida Department of State, Division of Corporations.

- Pricing: Filing fees vary based on business structure



Key Indicator 5: Register for State Business Tax

- Description: Register for Florida sales tax if applicable.

Key Indicator 6: Obtain Business License

- Description: Apply for a business tax receipt (BTR) from the City of Miami.

- Pricing: Varies based on business type and location

Key Indicator 7: Hiring Employees - Liability Status Application

- Description: Determine your liability status (sole proprietor, partnership, LLC, corporation) and register with the Florida Department of Revenue for employer withholding taxes.

- Pricing: No direct fee, but potential tax implications

Key Indicator 8: Selling Alcohol or Tobacco

- Description: Obtain additional licenses from the Florida Division of Alcoholic Beverages and Tobacco (ABT).
